Completion of the first intermediary report of the study on relations between Morocco and North America

IRES has finalized the first intermediary report of the study "Morocco - North America relations: current achievements and prospects for reinforcement" titled "Assessment of Morocco - North America relations". This report was devoted to the examination of Morocco's relations with the North America countries in their geoeconomic and geopolitical dimensions and the assessment of progress made in this area.

Morocco-South America Relations: Progress and Prospects of reinforcement



This seminar, organized on November 13, 2013, was devoted to the presentation and discussion of key finding of the study undertaken by IRES on this theme. It was attended by ambassadors of Argentina, Brazil, Chile and Peru as well as by Moroccan diplomats, public and private national actors and experts of international issues. The seminar emphasize

the strengths and weaknesses of Morocco's cooperation with South American countries at bilateral and multilateral level as well as the importance to expand the spectrum of this cooperation to key dimensions, such as technical cooperation, issues related to human development and human-cultural exchanges.

What place of North America within Morocco's strategic options?



This theme has been debated during the seminar organized on November 28, 2013, under the framework of the study related to the Atlantic dimension of Morocco's external relations. This seminar emphasize the importance of North America region for Morocco's external relations, with view to the opportunities in terms of development of

trade and investment, and the bilateral cooperation in some important areas of common interest.

Asia-Pacific dynamics and its impact on the global balances: what implications for Morocco?



Under the framework of its study on « Asia-Pacific dynamics and its impact on the global balances: what implications for Morocco? », IRES organized on December 26, 2013, a seminar on this theme. This seminar was attended by diplomats, public and private actors and experts on international issues. This seminar emphasized

the determinants of the centrality of the Asia-Pacific region within global geopolitical and geo-economic balances, the resulting direct and indirect effects for Morocco as well as the strategic actions the country should undertake in order to anticipate the geostrategic changes looming ahead.

IRES participation to the international conference on « Power sharing in the Middle East »

IRES took part to the conference, organized on December 5-6, 2013 in Hamburg, by the « German Institute for Global and Area Studies » (GIGA) on the theme « Power sharing in the Middle East ». IRES' communication focused on the prospects of social and political changes in the Middle East and on the Moroccan experience in terms of democratic transition.
