Asia-Pacific dynamics and its impact on global balances: what effects on Morocco?

IRES has finalized the report of the study mentioned above, which shed light on the implications of geostrategic dynamics of the Asia-Pacific on Morocco's international positioning and proposed some policy options to allow Morocco to anticipate these changes.

Relations between Morocco and Mauritania

The final report of this study examined the reality of cooperation between Morocco and Mauritania and the prospects of its development, taking into account key mutations occurring at the international and regional levels.

The report of the first phase of this study aims to establish an overview of the Morocco's economic diplomacy, through reference to some successful international experiences.

The relations between Morocco and South and East Africa countries

The preliminary report of this study was devoted to the analysis of relations between Morocco and South and East Africa countries, on political and economic levels. It also focused on the review of the perception of Morocco's image in these two subregions.

Launch of a study "Inequalities and social cohesion in Morocco: challenges and public policy orientations"

This second study of IRES on inequalities aims to examine the effectiveness of public policies of Morocco, in terms of reduction of inequalities, preservation of social cohesion and promotion of a middle class. The study will be dedicated, also, to make some policy proposals in order to improve the process of creation and distribution of national wealth.

Morocco, an emerging country?

IRES launched this study with the objective to establish a diagnosis of Morocco's performances compared to emerging countries and to propose relevant public policies so as to accelerate the process of emergence of Morocco and to improve its international positioning.

What prospects for the European policy of Norway?



This theme has been discussed during the conference facilitated by His Excellency Mr Are-Jostein Norheim, Ambassador of the Kingdom of Norway in Morocco, on December 4, 2014, which highlighted the main priorities of Norway, a country whose situation towards the European Union is similar to that of Morocco. Were also

discussed, the prospects of cooperation between Morocco and Norway on political, economic and social levels.

Croatia: new Member State of the European Union

The seminar dedicated to the presentation of the findings of this study, held on December 11, 2014, analyzed the main dimensions of cooperation between Morocco and Mauritania on the political, diplomatic, economic and socio-cultural levels as well as actions required to establish these relations on a strong and sustainable basis.

The seminar of December 25, 2014 was devoted to the presentation of the results of the study mentioned above. It focused on the examination of Morocco's relations with United States, Canada and Mexico and on the identification of the strengths and weaknesses of Morocco's positioning within North American region.

A Moroccan delegation composed of representatives of IRES and the Ministry of Foreign Affairs and Cooperation, visited Spain on November 7, 2014. It has focused on the Spanish experience in establishing its country brand as well as on the device dedicated to monitor and analyze Spain international image.

The Director General of the Institute, Mr. Mohammed Tawfik MOULINE, took part in the round table of experts organized by the "Multinational Development Policy Dialogue" under the Konrad Adenauer Foundation held in Brussels on November 13, 2014, through a communication on the progress made by Morocco in its transition to democracy and building of its development project.

Communication of IRES in the 4th edition of the Gulf Invest Forum 2014



IRES presented a communication on November 28, 2014, at the forum organized by the Union of Chambers of Commerce of the Gulf Cooperation Council (GCC), which highlighted the role of Africa as an area of projection of cooperation between Morocco and GCC countries as well as the required strategic levers to grasp the various

opportunities arising from this cooperation.

The International Forum on Peace and Security in Africa

The Institute has participated in the Forum mentioned above, which took place on 15-16 December 2014 in Dakar, through a communication of Mr. Said MOUFTI, Director of Research at IRES, on the specifics of the Moroccan approach of cooperation with African countries and the prospects of its strengthening.

Participation of IRES to the study sessions on economic intelligence



IRES took part in the study days organized by the Direction General of National Security, on December 17-18, 2014, through a communication of the Institute, which highlighted the specifics of IRES's foresight watch system and the contribution of the latter to enlightening Morocco's strategic choices.
